Extended Care Fee Schedule: Please check one

FULL TIME: \$230 per month for one child, each additional child in family is \$155 per month per child

PART TIME: \$8.00 per hour or half hour increments. Parents must specify which days their child will attend at the time of enrollment. maximum hours for part-time children will not exceed 10 hours a week. Part time Extension Program fees are due on the 15th of each month. Payments Not received by the 1st will have a \$10.00 late fee. These children will be regularly enrolled on a part-time basis and pay hourly. Morning extension must be dropped off before 7:40am. If you are part-time, you will be billed for 1 hour per the handbook.

LATE CHARGE: There is a \$30 charge per child if the parents pick up their child between 6:00 and 6:10 PM. After 6:10PM there is a \$1.00 per minute charge. This is to discourage late pickups and extra costs for the staff.

Full time Extension Program Fees are due on the 1st of each month. Payment not received by the 15th, will have a \$10.00 late fee.
